Work this week of July 12th:

Phase 2A (West Circle Drive from North Circle Drive to Inner Drive): Utility crew finished storm sewer to Inner Drive and began subcutting the street to place fabric, drain tile, and sand in preparation for Class 5 gravel.

Phase 2B (West Circle Drive from Inner Drive to Hickory Avenue): Grading crew finished removing curb, driveway aprons, and reclaimed asphalt. Utility crew began water main and water services.

Week of July 19th:

Phase 2A (West Circle Drive from North Circle Drive to Inner Drive): The grading crew is expecting to finish subcutting the street to place fabric, drain tile, sand, and Class 5 gravel.

Phase 2B (West Circle Drive from Inner Drive to Hickory Avenue): Utility crew anticipates finishing mainline water main, followed by services, then will be working on storm sewer.

Week of July 26th:

Phase 1 (North Circle Drive from West Circle Drive to East Circle Drive): Grading crew will be working on final grading in the boulevards in preparation for turf establishment work.

Phase 2A (West Circle Drive from North Circle Drive to Inner Drive): The grading crew will finish and tolerance Class 5 gravel in preparation for curb and gutter.

Phase 2B (West Circle Drive from Inner Drive to Hickory Avenue): Utility crew plans to finish water main services and storm sewer.

Revision to Project Phasing:

Contractor is proposing some small revision to the phasing and areas to be worked next in order to better maintain access and mobility for the contractor as well as the neighborhood. (See attached map). It is still the contractor's intent to substantially complete all phases this season with final paving and punch list work to be completed next spring.

Current Phases:

- Phase 1: Utility work and paving done
- Phase 2A: Utility work done. Road work to begin
- Phase 2B: Utility work to be completed around July 30.

The Next Phases on the current phasing plan are:

- Phase 3A: Inner Drive from West Circle Drive to Hillcrest Drive
Hill Crest Drive from North Circle Drive to Inner Drive **Work expected to begin 7/28**
- Phase 3B: East Circle Drive from North Circle Drive to Inner Drive
- Phase 3: Rogers Drive overlay to be paved with areas 3A & 3B
- Phase 4: East Circle Drive from Inner Drive to Hickory Avenue
- Phase 5: Hickory Avenue from East Circle Drive to 5th Street

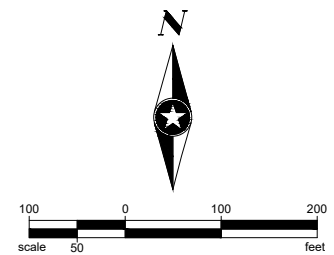
Please remember that schedules can change at a moment's notice because of weather, delays by subcontractors, or other unforeseen events.

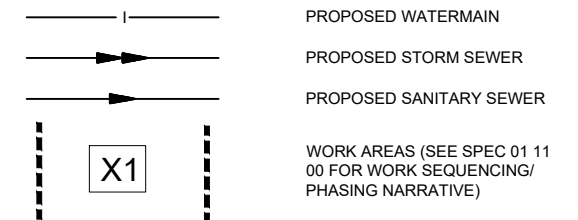
