Work this week of May 17th:

BCM's utility crew was working to complete the water services in the North Circle Cul-de-sac and complete the utility junctions in the intersection with W. Circle Dr.. Their goal has been to get out of the intersections and start restoring the cul-de-sac. Rain this week has of course effected progress on Thursday & Friday. The west end of the project is the most challenging as it is where all the water flows to. For those on North Circle Drive and especially that west end, we thank you for your patience. The proposed project is to remedy those issues, but the contract needs to get to get the facilities installed before things can start to get better.

Week of May 24th:

If conditions allow, the contractor intends to get into the cul-de-sac and begin subcutting the street and building the street section with fabric, sand, draintile and gravel. This work is the final steps in preparing for curb at a later date.

Utility work will continue with the installation of sanitary sewer main and services heading up the hill. And away from the West Circle Dr. intersection. Once the mainline sanitary and water are partway up the hill and out of the way for storm sewer work, it is possible that later in the week, the contractor might switch to installing the storm sewer from North Circle Drive to the Golf Course in order to begin managing some of the storm water effecting the cul-de-sac.

Week of June 1st:

Monday 5/31 is a Holiday, and the contractor will not be working in observance of Memorial Day.

During the week the Utility crew will continue working on North Circle Drive either on mainline Sanitary Sewer, Watermain, Services and/or Storm Sewer and working their way east.
