Permit Agreement and Signature

As the applicant for a Special Use Vehicle Operators Permit, I agree to the following and understand that violation of the conditions of this permit or any city or state law, rule, or code may result in the revocation of the permit or other legal action.

- 1. I understand the permit allows for use of the licensed vehicle on City and County streets within the corporate limits of the City of Montgomery and for the crossing of state highways; this permit does not allow for the operation of the special use vehicle on state roads or highways.
- 2. I understand that the licensed vehicle can only be operated during daylight hours unless equipped with OEM headlights and taillights.
- 3. I understand and agree that a licensed golf cart will display the slow moving vehicle emblem.
- 4. I will not permit the operation of the licensed vehicle by anyone under the age of 16 (MS 84.9256, subd. 1(b)(i)).
- 5. I will not permit the operation of a licensed ATV by any person under the age of 18 unless the operator and any passengers are wearing approved helmet (MS 84.9256 Subd. 2)
- 6. I understand and agree to follow all traffic laws.
- 7. I understand the licensed vehicle will not carry more passengers than the vehicle is designed to carry.
